In pursuance to the 13<sup>th</sup> Board Meeting of the Guwahati Metropolitan Drinking Water & Sewerage Board (GMDW&SB) held on 21.07.2022, the Water Tariff and Connection and Installation fees have been fixed as below. 1. The above water tariff will come into force with immediate effect.
2. Consumers will apply on the website GMDWSB.IN or through Mobile app.
3. The tariff fixed on as per the slab also indicated and for additional consumption of water, the next higher slab will be charged for the additional quantity.
4. The consumers will pay Rs. 500/- as application fee while submitting the online application through the payment gateway.
5. Water Connection will be provided to consumer/public area wise in phased manner.
6. In case of any failure, non-functionality or theft of Water meters, Board may levy a fixed tariff of Rs. 500 per month or the average of the past 3 months' consumption whichever is higher until new water meter is fixed.  
The consumer shall be responsible for the safe custody and care of the meter. As regards to theft of meters, the Board may provide a new one meter and collect the cost incurred in one or two monthly installments from the consumer along with the monthly tariff.
