2. Consumers will apply as per prescribed format, which may be down loaded from the Guwahati Metropolitan Drinking Water & Sewerage Board website. gmdwsb.assam.gov.in

3. The tariff fixed is as per slab indicated and for additional consumption of water, the next higher slab will be charged for the additional quantity of water.
4. The consumers will deposit Rs. 500/- as processing fees for depositing the Application Fees in the form of Demand Draft/Bankers Cheque/Indian Postal Order (IPO) in the name of the Managing Director, Guwahati Metropolitan Drinking Water & Sewerage Board.
5. Water Connection will be provided to the consumers/public area-wise in phased manner.
6. Consumers/Public may give their views on the tariffs in the Jal Board website gmdwsb.assam.gov.in or as hard copy addressed to the Managing Director, Jal Board within 15 (fifteen) days failing which water tariff may be treated as final.
