Administrative Approval for the works under JICA assisted Guwahati Water Supply Project.

Sir,

With reference to the above subject, it is stated that the JICA assisted Guwahati Water Supply Project was started in the year 2009 with financial assistance from Japan International Cooperation Agency, roam Agreement in this regard between JICA & Govt. of India was signed on 31<sup>st</sup> March, 2009.

As per schedule 7 of the Loan Agreement with JICA, the procedure for payment to the contractors was to be done through Transfer procedure, i.e., Direct Disbursement of fund to contractors by JICA on recommendation of Project Management Consultant (PMC) and PIU. Since, the payment was made directly by JICA and not by PIU, the procedure for sanctioning and releasing of fund did not involve issuance of Administrative Approval (AA) or Financial Sanction (FS).

However, subsequently, the Department of Economic Affairs (DEA) under the Ministry of Finance vide its letter No. 1/3/2010-Jap.III dated 27/10/2015 informed that no disbursement will be made with transfer procedure with effect from 1<sup>st</sup> April, 2016. In place of Transfer procedure, a new system namely Reimbursement procedure was to be followed. Under this procedure, funds are to be released from the PIU to the executing agencies after the funds are received from the State exchequer and subsequently, after spending this amount in will be reimbursed through the Ministry of Finance by JICA. Accordingly, this procedure is being followed since 1. April, 2016 and funds are being released after issue of Financial Sanction. However, it is felt that it is appropriate to issue Administrative Approval for total awarded contract value against each package for future convenience in financial and accounting procedure. Therefore, it is now decided to issue the deemed Administrative Approval (ex-post facto) against the contract value of these contract packages as shown below for convenience of resord keeping and accounting. Accordingly, the contract award against each package is hereby notified as deemed Administrative Approval as shown below vide No. and date in the Column 'two' for granting in future.

- (iv) Observation of all financial rules and procedures etc.
- (v) Compliance of CVC guidelines and provision of AFRBM Act, 2005
- (vI) The construction of works must be completed within the estimated cost in all respects without involving cost and time overrun
- (vii) There should not be any change of proposed works. Diversion of fund from one work to another will also not be entertained under any circumstances.
- (viii) Each financial release/Sanction order shall quote the Administrative Approval No. as provided above.


