
With reference to your letter cited above, this is to inform that your acceptance of the offer to extend the scope of the existing ICDC to include balance work of PMC has been received.

In this regard, it is also confirmed that :-

- (a) You have the flexibility of readjusting the remuneration with the resources identified keeping overall ceiling of INR. 75,639,000/- (INR seventy five million six hundred thirty nine thousand) only without diluting the quality of resources. .
- (b) The PIU has no objection in selection of premises for office to be set up within the city of Guwahati and ideally all ICDC personnel be seated at one place though.
- (c) As regards para (iv) of your acceptance letter dated 01/03/2016, any such requirements that cannot be covered under the existing PMC portion, will be provided on need basis as per the essentiality.
- (d) It is further confirmed that the proposal does not include –
 - (a) Architectural Design and supervision services related to the Jal Board Building.
 - (b) Service Tax which shall be charged at prevalent rates.
- (e) The request for mobilization Advance shall be considered in due course.
- (f) The rates beyond 12 months of the proposed assignment will be decided through mutual agreement.

In view of above, it is requested to submit your final acceptance of the offer at once and commence works from 10/03/2016 so that the PIU can forward the draft agreement as amendment to the existing ICDC Contract so as to cover this additional scope.
